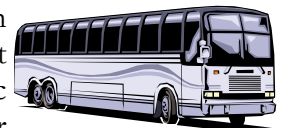

HARRISON GORDON WINS \$1.5 MILLION DOLLAR SETTLEMENT

An 86-year-old man who suffered a brain injury and his 81 year old wife, who suffered minor injuries, settled their case for \$1.5 Million Dollars.



The clients were backseat passengers in an automobile driven by their son-in-law, when he made a left hand turn into a parking lot and was struck by a bus. Our client suffered a skull fracture, which caused a brain hemorrhage that required a craniotomy as well as other injuries. Our client maintained that he was left with a significant cognitive impairment that manifested in memory difficulties and confusion. Defense counsel contended that his memory loss and other cognitive problems were the result of dementia and not as a result of the accident disputed this. ER records indicated early signs of dementia. However, our neurological expert attributed 90% of the cognitive problems and memory loss to the accident and only 10% to the early onset of dementia. There was a dispute by both parties as to whether or not the driver of the car in which our clients were passengers was in the right or left lane when the bus struck him. We had to obtain a traffic reconstruction expert to determine who was at fault for the crash and how it occurred. There were numerous depositions of all parties, medical experts, and the police officer that came to the scene of the accident and traffic reconstruction experts. This case was further complicated by the fact that clients resided in both New York and Romania and spent considerable time in both places. Darlene Abry, our paralegal was instrumental in many important aspects of this and other cases. This case was finally settled through Mediation before a Retired Superior Court Judge. ■



MILLIONS FOR ENVIRONMENTAL CLIENTS



Partner, Michael Gordon and his team of associates, Kelly Pokrywa and Steven Schepps, have secured more than \$11 Million Dollars in environmental settlements recently for clients injured or inconvenienced due to environmental contamination in their neighborhoods.

Plaintiffs successfully represented by Gordon & Gordon, P.C. include residents surrounding an abandoned manufacturing facility, neighbors and homeowners in the vicinity of a gasoline station with leaking underground stor-

\$600,000 DOLLAR SETTLEMENT AGAINST BAR SERVING LIQUOR TO INTOXICATED PATRON AND AUTOMOBILE DRIVER

Harrison J. Gordon recently settled a case against a Tavern for serving liquor to visibly intoxicated patrons. Our client and his friends were patrons at a local tavern and left visibly intoxicated. The driver lost control of the vehicle and struck a tree, which immediately killed the driver and the front seat passenger. Our client, who was a back seat passenger, sustained a skull fracture and subdural hematoma – Plaintiff was kept in medically induced coma and suffered severe cognitive injuries. This case was previously settled with the driver's insurance company for \$100,000.00 but, Harrison Gordon contended that the defendant tavern served the driver when he was visibly intoxicated and the plaintiff brought a dram shop action against the bar that resulted in the \$500,000.00 additional settlement. The full policy limits of the automobile policy and tavern insurance policy were exhausted.



STEVEN SCHEPPS RECOVERS \$150,000.00 FOR DRIVER

Our client was a truck driver who was driving her truck when she was struck by an automobile in snowy conditions. The other driver slid into our client's truck.



The defendant contended that our client was driving too fast for conditions. Our client suffered injury to her rotator cuff that required surgery and also injured her back and knee which were previously injured.

The defendant contended that her injuries healed well and that her current injuries were from a work related incident and not from this automobile accident. Defendant also stated that our client's back and knee injuries were from a pre-existing condition.

Steve did a great job by obtaining \$150,000.00 for our client.

While in China, Mr. Gordon led off the lawyers roundtable with a presentation entitled: "Twenty Five Years of Environmental Law and Litigation Fighting for People and the Environment: A Personal Journey" which was followed by a day long discussion on the status of environmental law in China and proposed changes that could result in greater rights for victims. During his weeklong visit as the invited guest of CLAPV, Mr. Gordon accompanied the lawyers from CLAPV to Inner Mongolia to conduct a site inspection to investigate the possible links from chemical emissions to the destruction of fruit orchards. Mr. Gordon lectured to lawyers and law students about methods to analyze the potential for proving the impacts originated from a local factory to cause the damage to the orchard.
